## DOGS IN VEHICLES ON HOT DAYS

Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog. If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.

**Soft Crates:** The Kennel Club has asked that we draw attention to the potential health and safety implications concerning the use of soft crates as in its view, they do not offer sufficient protection to dogs. They have asked that we point out that dogs should not be left unattended in soft crates. There have been instances where dogs have escaped from soft crates which have not been securely fastened to benches, or that have been left at ringside.

We therefore ask that if you use soft crates, you do not leave the dogs unattended, either in the hall, or in an open car in the car park.
