

20. The show will be held under K.C. Rules and Regulations in force at the date of publication of the Schedule.
21. The Club nor its Officers and Committee will be responsible for any claim for injury or compensation or loss of property occasioned by or arising out of holding of the Show or by reason of act or default of any person in attendance or present thereat.
22. Any owner exhibitor handler or person in charge of a dog is required to remove, as soon as possible, any fouling caused by their dog(s) at any Kennel Club licensed show within the licensed venue and within the environs of that event, including car parks and approaches. Any organization holding a Kennel Club Licensed event it required to provide an adequate number of receptacles for the disposal of such fouling.
23. The Committee is empowered to exclude any dog which is not in a fit state for competition owing to disease savage disposition or any other case not in a fit state for exhibition and if such exclusion takes place before or after the dog is judged the entry fee will be forfeited K.C. Show Reg. 15.
24. No dog other than those entered for the Show will be allowed within the precincts of the Hall whilst the Show is in progress.
25. The Committee of the show can accept no responsibility for products advertised or sold by the Hall whilst the Show is in progress.
26. The Committee of the show can accept no responsibility for products advertised or sold by stand holders at the show and remind exhibitors that grooming products on sale may not meet the requirements of the regulations for the preparation of dogs for exhibition (K.C. SR (f))
27. Exhibitors passes will not be sent out. Please send a SAE. If you wish for acknowledgement of entries.
28. Any persons or persons who have children in their care will be held responsible for any damage caused by them or their children at this show.

#### REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F (B)

1. These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or for disciplinary action under Kennel Club Rule A11.
- a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained there at.
- b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A11.
2. a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show.
- b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
3. No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:-
- a) Operations certified to the satisfaction of the General Committee.
- b) The removal of dew claws of any breed.
- c) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown.
- Nor must anything be done calculated to in the opinion of the General Committee to deceive.
4. The General Committee without previous notice may order an examination of any dog or dogs at any Show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.
5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may, however, be lodged by an official of the Show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
6. Any objection by an individual related to an infringement of these regulations must be made in writing to the Show Secretary at his/her office before the close of the Show & the individual must produce evidence of identity at the time of lodging the complaint.

## **RULES AND REGULATIONS**

1. The show will open at 8.30 a.m.
2. Dogs will be received at any time but it is the exhibitor's responsibility to ensure that dogs are available for judging when required.
3. **Judging will commence at 09.30 a.m.**
4. Exhibits may be removed from the Show after their judging has been completed. The Show will close half an hour after all judging has been completed.
5. **ENTRY FEES :** Members 1st Entry - £12.00 per dog - subsequent entries with the same dog £1.50 :Non -members - 1st Entry - £14.00 per dog - subsequent entries £2.50 per class. Special Award Classes £3.00 per class. Not for Competition - £1.00 per dog (English Setters Only). Catalogues (pre-paid) £3.00 per show.
6. Prize Money - £10.00 for B.I.S., £10.00 for B.P.I.S., £10.00 For B.V.I.S.
7. The Committee reserves to itself the right to refuse entries.
8. Puppies under six calendar months of age on the first day of the show are not eligible for exhibition.
9. The mating of bitches within the precincts of the show is forbidden.
10. **Best Puppy in Show** Where a Best puppy in Show competition is scheduled the Best Puppy in Show is a puppy which has competed and received a first prize in a class at the same show. A Puppy is a dog of six and not exceeding twelve calendar months of age on the first day of the Show. Where the Best in Show is a puppy it should automatically be awarded Best Puppy in Show respectively. Similarly, if the Reserve Best in Show is a puppy which has only been beaten by an adult dog it should also automatically be Best Puppy in Show respectively. Consequently, selection of Best Puppy in Show must follow the selection of Best in Show respectively.
11. **Best in Show** Best in Show must be selected from the exhibits declared Best of Sex but only if they have received a first prize in a class at the same show. If a Reserve Best in Show is to be selected, the eligible dogs are those declared Best Opposite Sex and the Reserve Best of Sex to the exhibit declared Best Opposite Sex and the Reserve Best of Sex to the exhibit declared Best in Show. The dogs declared Best in Show and Reserve Best in Show must not compete in any subsequent competition.
12. Exhibits will not be admitted to Best in Show competition after a period of ten minutes has elapsed since the announcement that exhibits are required for judging, unless they have been unavoidably delayed by previous judging not being completed on time, and then only with permission of the Show Management.
13. Exhibitors must not pick up dogs by their tails and leads when lifting them nor handle a dog in a manner which causes its feet not to touch the ground when on the move. This is not acceptable. Exhibitors should note that such practice would constitute harsh handling and reports of such practice will be referred to the Committee under Kennel Club Show Regulations F11.
14. All exhibitors must be familiar with Kennel Club Regulation F (Annex B) - Regulations for the Preparation of Dogs for Exhibition.
15. All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
16. **DOGS IN VEHICLES ON HOT DAYS.** Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of Kennel Club Regulations in this respect may be referred to the General Committee for action under Kennel Club Rules and Regulations.  
Your dog is vulnerable and at risk during hot weather and the Kennel Club offers the following guidance to help guide you through the do's and don'ts travelling to and whilst at KC licensed events.  
When travelling to a show please take a moment to consider whether the route to the show is on a busy holiday route, and leave earlier to avoid increased time in traffic jams.  
If your vehicle is not air-conditioned seriously consider whether travelling to the show is a good idea at all.  
The vehicle should be as fully ventilated as possible, and plenty of stops should be taken, with lots of water available to drink.  
Ensure your dog is not sitting in full sunlight. There should be plenty of free flowing air around the dog.  
When at the show, never leave your dog in the vehicle.  
Keep the dog in the shade – take your own shade for example a large umbrella and always have plenty of water available to drink so your dog stays well hydrated.  
Avoid your dog taking part in unnecessary exertion, or from standing in exposed sunlight for extended lengths of time.  
Remember, if you feel hot your dog is very likely to feel much hotter and dehydrated, and this could lead to dire results. Please look after your dog's welfare.  
**WARNING: IF YOUR DOG IS FOUND TO BE AT RISK FORCIBLE ENTRY TO YOUR VEHICLE MAY BE NECESSARY WITHOUT LIABILITY FOR ANY DAMAGE CAUSED.**
17. Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of Kennel Club Regulations in this respect may be referred to the Board for disciplinary action Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any show licensed by the Kennel Club. This shall apply at the venue or within the precincts of the show.
18. Not for competition entries will be accepted. Details of each dog so entered must be recorded on the entry form and must be Kennel Club registered.
19. No modifications will be made to this schedule except by permission of the Board of the Kennel Club, which will be followed by advertisement in the Canine Press wherever possible.

## Covid-19 Statement

This show will be held in line with Kennel Club and Government guidelines in place at the time of the show. The designated COVID-19 Safety Officer is Mrs. Jayne Pearson. By entering the show you agree to abide by the rules set out below. Anyone not abiding by the rules will be asked to leave.

If an exhibitor or anyone in their household or bubble has Covid-19 related symptoms or has tested positive for Covid-19 in the past 14 days they must not attend the show.

A 'Track and Trace' form must be completed and placed in a box on the Secretary's table upon arrival. This form will be emailed to all Exhibitors, Judges, Stewards and Committee along with a copy of the Risk Assessment prior to the Show Day.

### ON THE DAY

1. On arrival at show, register at Officials table, everyone to hand in completed 'Track and Trace' forms and collect paid for catalogue and ring number. Please be aware that social distancing may need to be observed depending on restrictions at the time.
2. Always wear face mask (unless with Medical Exemption ID shown) in any buildings and in and around the rings. The judges will also wear a face mask whilst judging the dogs.
3. The judge will sanitise their hands after judging every dog. The handler will show the dog's teeth to the judge.
4. Hand disinfectant facilities will be provided around the show ring and venue.
5. The show will be held outdoors making it easier for Covid-19 regulations and will only be held inside (Crocker Hall 1) if excessively wet.
6. There are a limited number of chairs available at the showground, please bring your own if possible.
7. If required please social distance from exhibitors and ringside.
8. Parking spaces will be available around the back, side and front of Halls. We ask exhibitors to park safely, sensibly and observe social distancing rules.
9. Refreshments will be available on site throughout the day.

## NESS Committee are pleased to provide a short resume for our 2021 Championship Show Judges

### Mr. Ronny Blomme (Norcroft)

My first dog was a non-pedigree bred Irish Setter male which was in 1976. But soon I was very much interested in the English Setter as well which resulted in an UK import bitch named Sh.Ch. Crimbledale Cool Capers in 1988, bred by the late Sue Loynd. We bred very successfully a few generations from this bitch until we rather unexpectedly lost the line. After being in these breeds for 10 years

I started judging Irish Setters in Belgium for the first time at CAC level (CC level) in 1988 and soon followed with the other Setter breeds and English Pointer. My judging interest lies mainly in the British Gundog breeds, thus followed later judging Spaniels, Retrievers and Waterdogs, and qualified as a group judge for FCI Group 8. Over the years judging has taken me to many countries across Europe including the World Show in Bern, Switzerland in 1994 and to Australia judging the Irish Setter Specialty. After over 30 years judging I still judge only Gundogs, but above all judging Setters & Pointers will with no doubt always be my preferred breeds to judge.

I have visited the UK shows countless times, the first time in 1981 which opened a new world for me, and in my opinion it is still the place to learn and see the true type. I have visited the NESS Championship show many times in the past as it was held the same weekend as the ISAE show which was ideal for me to have 2 breed shows in one weekend. The UK shows, and the type of dogs seen there, the breeders and judges with lifetime experience in their breeds, has always been, and always will be, my consistent guide in my judging career.

After having judged at several UK open shows from 1990, my first UK CC appointment was in 1999 at the Irish Setter Association of England club show. My first time awarding CCs in English Setters was in 2016.

I am very honoured, and dare to say proud as I never expected to would reach this level in my judging career and this will be my 10th set of CC's in the UK across the 4 Setters breeds and have awarded 12 sets of CC's in total. I am honoured and thankful to the organizers of all those shows for having invited me to judge at their shows and of course also for the support of the UK breeders and exhibitors over those 40 years. First time judging UK Gundog Group, which really was beyond my expectations to ever do this in the UK, was also planned for 2021 but unfortunately Covid19 decided otherwise.

I thank the NESS for having invited me to judge on their show and I really am very much looking forward to it.

### Mrs. Rhoneen Schoneville (Balvenie) – Judge for Special Classes

I have been involved with dogs and showing since I was 16 years old. Starting out with an Irish Setter and then moving onto English Setters soon after that. I obtained the Balvenie affix that is now shared by my parents and partners of our lines. I had a break from the show world when I had a young family but returned to my passion with GSPs and showing our English Setters. I started judging in 2016 and have enjoyed learning about this role and enhancing my knowledge of the breeds I judge. I have completed an English Setter BAD and loved the opportunity to learn more about the lovely breed from the experts.
