All dogs must be REGISTERED at the Kennel Club in the name of the exhibitor. If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of postage of such applications may be required by the Kennel Club. Puppies under 6 months of age on the first day of the Show cannot be entered for competition. On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after its name. Please put classes in numerical order and USE BLOCK CAPITALS throughout when completing this entry form. The Kennel Club Authority to Compete number (for dogs registered and resident outside the UK) must be stated or the entry will be returned. PLEASE CHECK ALL DETAILS BEFORE POSTING.

I/We further declare that I believe to the best of my knowledge that the dogs are not liable to disqualification under Kennel Club Show Regulations.

## **DOGS IN VEHICLES ON HOT DAYS**

Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog. If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.

<u>Soft Crates:</u> The Kennel Club has asked that we draw attention to the potential health and safety implications concerning the use of soft crates as in its view, they do not offer sufficient protection to dogs. They have asked that we point out that dogs should not be left unattended in soft crates. There have been instances where dogs have escaped from soft crates which have not been securely fastened to benches, or that have been left at ringside.

We therefore ask that if you use soft crates, you do not leave the dogs unattended, either in the hall, or in an open car in the car park.
